WHAT IS PAN (PERMANENT ACCOUNT NUMBER)

- 1. PAN is a unique identification number, which is issued to all the taxpayers and TDS withholding agents throughout the kingdom. PAN identifies each taxpayer and TDS withholding agents uniquely countrywide.
- 2. PAN is necessary to process taxpayers and TDS withholding agents using computer systems.
- 3. PAN is allotted only once in the lifetime of a taxpayer or TDS withholding agent. It never changes.

As you are withholding taxes on behalf of others such as contractors or employees, we need to provide you with PAN in order to clearly identify and track your payments in our computer system.

You are neither a taxpayer not do you need to file an income tax return or VAT return.

HOW DO YOU REGISTER

- 1. Fill in the "Application for Permanent Account Number (PAN)" and submit it along with the sketched map of the location of your main office to your Inland Revenue Office.
- 2. An inland revenue official vets your application with regard to correctness and completeness.
- 3. If found correct and complete, you will receive a "Temporary Account Number Registration Certificate". It is valid for 3 months.
- 4. Fetch your "PAN Card" from your Inland Revenue Office within 3 months.

NOTE: You may send any authorised person to submit the application form and to fetch the "Permanent Account Number (PAN) Registration Certificate". However, you must send an authorisation letter (as per prescribed rule) with that person.

HOW DO YOU FILL IN THE FORM

- Section 1,B Fill in details of the registration obtained from the company/firm registration certificate.
- Section 2 No need to fill in the mailing address if it is identical to the location address.

 Area means the area in which some districts are subdivided into. You may need to ask an inland revenue official for the correct area code.
